NOW THIS INDENTURE WITNESSETH AND IT IS AGREED TO AND DECLARED AS FOLLOWS:

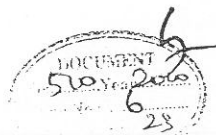
1. The name of the trust shall be: **"VOICE OF HEAVEN CHARITABLE TRUST"**
2. The registered office of the Trust shall be situated at Door No.5, Customs & Central Excise Colony, Okkiyam Thoraipakkam, Chennai -600 096, or such other place or places which the trustees may desire from time to time as rented basis.
3. The first trustees of this trust shall be the following persons:

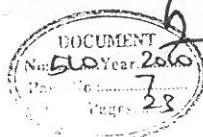
5. The objects of the Trust are:

a. To Establish an orphanage for the benefit of orphans.

b. To Establish an Educational institution.

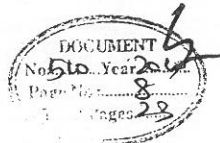
c. To impart training and education, rendering of medical relief of all kinds and rendering all kinds of social service to public irrespective of caste, creed and religion.

d. To conduct work houses or industrial workshops or centres, orphanages, old age homes, asylums, rural health care centres, welfare centres, youth centres and training centres and similar charitable works and services for the benefit of public.

- e. To impart academic (School and college courses), technical instruction and professional and adult education to deserving men and women, of all age, without any consideration of caste, creed, or religion.
 - f. To provide shelter to the destitute and orphans in boarding houses;
 - g. To raise and acquire funds, local and foreign, to use any gift, donation or foundation, to undertake and carry out the offices, duties and functions of trustees, managers and administrators.
 - h. To teach charity and truths for the benefit and upliftment of all persons irrespective of caste, religion, language or social status and to provide suitable formation and training to the people for the promotion of the above aims and objects;
 - i. To do all such matters and things necessary, conducive, incidental or ancillary to promote and further the objects of the trust.
6. To submit views or make representations before authorities committees, or other bodies including the general public, on any subject affecting the interest of the people of any legislation or regulation, which may appear to be in the trust in accordance with and in furtherance of its objectives.



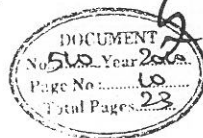

7. To Purchase, take on lease and license, or by way of mortgage or in exchange or otherwise acquire or held any movable property, rights, easements, or privileges and to improve and develop any or all of them as may be deemed necessary or convenient for any of the objectives of the Trust.
8. To invest the funds of the Trust in such manner as may from time to time determined.
9. To negotiate and enter into any arrangements, with other persons, bodies, government, municipal or local authorities that may seem necessary, incidental, ancillary or conducive to all or any of the objectives of the trust.
10. To enter into such contracts or agreement as the trust may think fit for the purpose of the trust and for such or any of these purposes to retain or to employ, from time to time, skilled, professional, technical, commercial or other advisors and personnel (full time/part time), and to pay or their services such fees or remuneration as the trust in its discretion considers expedient;
11. To borrow any moneys required for the purposes of the trust upon such terms and securities as may be determined by the trust.
12. To accept, hold or administer any gifts, grants, donations, contributions, in kind or money whether upon trust or obligation which may be deemed conducive to any of the objective of the trust, and in this connection to issue appeals and applications for money and funds.



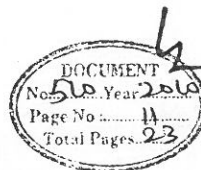

13. To donate, aid, contributed pecuniary or otherwise, to any person, association, body and / or movement, which are not of religious nature, in keeping with the objectives of the trust.
14. To sell, assign, mortgage, lease, exchange or otherwise transfer or dispose off, turn into account or otherwise deal with, all or any properties movable or immovable or immovable of the trust as conducive to the working of the trust.
15. To establish, conduct, manage, administer, develop such institutions as are found to be expedient or necessary from time to time for implementing, realizing, carrying out the aims and objects, policy and programmes of the Trust such as establishment of schools and college, home for the aged, orphanages, medical centres and such similar institutions.
16. To print, publish, issue and exhibit any journals, magazines periodicals, books, papers, pamphlets, advertisements, reports, lectures and other reading matter for the diffusion of useful knowledge and for the promotion, benefit and advancement of the Educational, Cultural, Social, Technical, Charitable activities of the Trust.
17. To build, construct and maintain buildings and structures of whatever nature and kind as are found to be expedient for the furtherance of the objects of the Trust.

18. To Appoint from time to time the personnel or staff needed by the Trust on such terms and conditions and the managing committee shall deem fit and to give Charitable aid and to provide for the welfare of the persons employed by the Trust and their dependants by establishing provident and Benefit funds and institute schemes of pension, gratuity, allowances, loans and other assistance to such persons in such cases as the Managing Committee may deem fit.
19. To provide residential accommodation free of cost and to educate, train and assist financially in the education and training of teachers, social workers, students and other personnel for the purposes of the Trust.
20. It is hereby declared that the activities of the Trust will be of purely charitable nature not motivated for profit.
21. The Funds of the Trust will not be applied for any religious purposes or given to any religious institutions.
22. The Trust shall acquire immovable property with the prior approval of the Director of Income Tax (Exemptions), Chennai. The Trust shall not alienate the immovable property of the Trust without the prior approval of the Director of Income Tax (Exemptions), Chennai.

23. The objects are independent of each other and the trustees may, from time to time, apply the funds of the trust in carrying out all or any one of the objects of the trust.
24. The founder has full power to appoint any person as trustee of this trust. If in such an event, the founder appoints co-trustees, the body of trustee shall be called the board of trustees.
25. A Trustee must be an individual and no corporate body shall be appointed as a trustee of this trust.
26. Mr. G. Banerje shall be the first managing trustee of the trust and shall hold the office of the managing trustee of this trust for his life or until he resigns.
27. Wherever any person appointed as a trustee of the trust hereby created, disclaims or any such trustees either original or substituted dies, or is, for a continuous period of fifteen months absent without leave of the board from the Indian union or leaves the Indian Union for the purpose of residing abroad or desires to be discharged from the trust, or becomes in the opinion of a majority of co-trustees unit to act in the trust or is disqualified, a new trustee may be appointed in his place by the board.
28. The administration, direction and management of several institution and establishments in terms of the trust hereby created shall, subject to the supervision, control and

direction of the board, be with the managing trustee. In the event of any difference of opinion, the opinion of the managing trustee shall prevail.

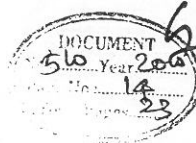
29. The funds and properties of the trust shall be the said sum of Rs. 1000/- (Rupees One Thousand only) and all the every other funds and properties in future gifted, conveyed and transferred of the board for the purpose of carrying out the objects of the trust, hereby created, additions, accretion and augmentations, to the aforesaid sum and investment of the said funds as set out infra.
30. The Funds of the Trust shall be invested:-
- a. In any of the securities authorized by section 20 of the Indian Trust Act 1882.
 - b. In the purchase or acquisition or construction of land or buildings or water tanks or other immovable properties provided that no such investment shall be made except with the previous sanction of the board recorded by means of a resolution passed at a meeting of the Board. The necessary approval from Income Tax authorities and other authorities shall be obtained.
 - c. In current or savings bank or fixed deposits with banks and in the modes and forms specified under the provisions of the Income-Tax Act and the rules made there under as approved by the Board by means of a resolution recorded at a meeting of the Board.

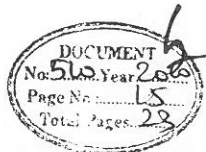
d. The bank accounts shall be operate by the managing trustee Mr. G. Banerje and the trustee Mrs. Flory.

31. Except as otherwise, provided herein, none of trustees, for the time being, of the Trust shall have power jointly or severally to mortgage or charge alienate any of the Trust properties.
32. In the professed execution of the Trust and power hereto no Trustee shall be liable for any loss of the Trust properties arising by reason of any investments made in good faith except willful or deliberate fraud of wrong doing on the part of the Trustee who may be subject to be made liable.
33. Subject to the superintendence of the Board, and subject to express provisions herein contained, the Managing Trustee shall have every power for the purpose of managing, conducting and administrating the affairs of the educational institutions, hostels, medical institutions, water tanks, universities and other establishments conducted by the trust.
34. The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and disbursements and other liabilities incurred and of the assets acquired and for an audit every year of the accounts of the Trust and of the income and expenditure relating thereto and for this purpose the Managing Trustee shall appoint in consultation with the Board, and independent auditor or auditors.

35. The Managing Trustee shall have power to purchase, from time to time, such materials and things as may be necessary for the said educational institutions, hostels, reading rooms, water tanks, medical institutions, universities and other establishments.
36. The Managing Trustee may, if and when he desires, delegate for a temporary period his authority in respect of the administration of the institutions to one of the Trustees.
37. The Managing Trustee shall have the custody and control of all the documents of title to the properties of the Trust and all other documents, accounts and other papers, relating to the Trust and the same be opened to inspection by any Trustee on reasonable notice during office hours of the Trust office.
38. The Managing Trust, shall on request by any Trustees, furnish such information as the latter may reasonably require in respect of any mater pertaining to the Trust.
39. The Managing Trustee shall once in every year, not inter than the 30th day of September, place before the Board for the consideration of an adoption by the Board, the income and expenditure account for the year ending on the previous 31st day of March and the Balance Sheet as at that date, with the Auditor's Report or such information and explanations as the Board may require for proper understanding of the accounts and the statements placed before it.

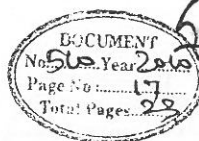
40. The Managing Trustee shall be the executive officer of the Board and as such he/she shall have power and authority for and on behalf of the board:

- a. To Carry out the resolutions of the Board.
- b. To sign papers, receipts and documents.
- c. To pay money payable by the Trust and demand and get receipts therefore.
- d. To demand and receive moneys due to the Trust and issue receipts for the moneys so received.
- e. To open current and deposit accounts in the name of the Trust in such accounts on behalf of the Trust.
- f. To make, draw, endorse, accept, sign, negotiate or transfer, cheques, promissory notes, hundies, bills for exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, Government Securities or other securities.

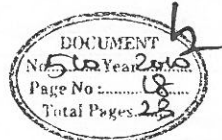
- g. To lease out and properties of the trust which are ordinarily leased out for any period of time as may be decided by the Managing Trustee or Board.
 - h. To Arbitration or abandon, legal proceedings or disputes and to sign all papers in connection therewith.
 - i. To appoint, employ, remunerate, remove, suspend, discharge, dismiss, reemploy, replace, transfer and accept resignation of staff and workers permanently temporarily or otherwise.
 - j. To Call for the meeting or meetings of the Board and
 - k. To execute all documents on behalf of the board.
41. There shall be an annual meeting of the Board not later than 31st September, when the annual audited statements of accounts shall be considered and adopted. The Managing Trustee

shall, at such meetings, place before the Board a report of the working of the several institutions conducted and maintained by the Trust. The Managing Trustee shall give atleast 14days written notice of the meeting to the Trustees specifying the day, date, place, time and agenda of the meeting. Along with the notice the Managing Trustee shall also send to every one of the Trustee a copy of the audited statements of accounts intended to be placed before the meeting.

42. The Board shall consider at the said meeting the report of the Managing Trustee and that of the auditor and the audited accounts and if the Board proceeds to approve and adopt them, such approval and adoption shall be by means of a resolution to that effect. The Board shall also transact such other business at the meeting about which due notice had been given as aforesaid. All the resolutions passed by the Board shall be recorded in a separate book. In the absence of the Managing Trustee any one of the Trustees may be elected at the meeting to preside over the meeting.
43. The Trust shall conform to the provisions of the Indian Trust Act, 1982, in all matters not expressly provided for herein but in case any difficulty or double arises on any question in respect of the management or administration of the Trust or any matters falling hereunder the Managing Trustee may on behalf of the Board, apply to the court for opinion, advice,

direction, or order and the Trustees acting upon the direction, if any, of the court shall be deemed so far as regards their responsibility to have discharged their duties in respect thereof.

44. The Managing Trustee or the Board may after its constitution may from time to time, make and prescribe rules, regulations and bye-laws regulating its carrying out of the objects of Trusts, including the prospectus and application form for admission into the educational institutions, the code of conduct for the staff, students and employees, the payment of salary and other benefits and the procedure for taking disciplinary action against them.

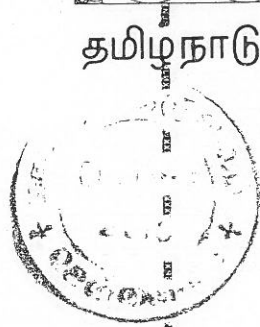
45. The properties and funds belonging to the Trust shall be utilized for such other rallied purpose as the Board may determine.
